Bydd adroddiad Diwedd Prosiect yn cael ei gwblhau a'i ddychwelyd erbyn **dydd Gwener 7ail o Ebrill 2023**.

# GWIRVOL YOUTH LED GRANTS Terms and Conditions

In accepting the Youth Led Grant funding, you are also accepting the following terms and conditions as set out by Ceredigion Association of Voluntary Organisations and the Youth Led Panel

1. The Voluntary Organisation must use the grant for its approved purpose (i.e. as per your budget breakdown in your application form). Any **proposed** deviation must be reported to Ceredigion Association of Voluntary Organisations.
2. As a corollary to 1. above, the Voluntary Organisation must agree to repay the grant to the extent that it is not used for the purpose for which it was given.
3. All projects must be completed by **31<sup>st</sup> March 2023**.
4. If the organisation does not have a constitution, they must agree to work with CAVO to ensure good governance associated with grant management and repayment.
5. Successful project applicants will agree to use the CAVO and Volunteering Wales logos and refer to the Gwirvol scheme in any project promotion and publicity.
6. As a condition of receiving the grant, the Voluntary Organisation will be expected to put into place arrangements for monitoring and evaluating the use of the monies. The organisation must report back to Ceredigion Association of Voluntary Organisations (CAVO) in line with the monitoring and evaluation requirements set down. An End of Project report will be completed and returned by **Friday 7<sup>th</sup> April 2023**.
7. The panel requests that photographs, articles, and media coverage are submitted with the End of Project Reports.
8. Receipts must be returned with the monitoring form for any expenditure for £50 or over.
9. The Youth Grant Panel will carry out progress checks / visits may be made during the term of the grant.
